Again we are encouraging our young people to use bicycle instead of motor bike and individual car for reducing the Green House Emission into the Environment. Also in our awareness Programmes for mitigation of climate change we are already addressing to our local people that the transportation is the second leading source of green house gas emissions. We have suggested the public to reduce travelling by air flights to protect Ozone layer from further depleting. It would also help to reduce Green House Gas emissions. To overcome of Global warmness we are continued to plant more tree and fruits plants to protect Environment and promoting in wide range of biodiversity in the ecosystem. Being close to the people, we always determine the extent of impact of climate change on local communities. Local communities can help build up their capacities to undertake the needed adaptive actions to reduce vulnerability, mitigate risks and build resilience. We also help our local farmers for adopting resilient farming practices across the agricultural landscape, strengthening rural economics among farmers and communities. In the mean while we teach our farmers to conserve our Natural Resources so that our future generation may learn to use Natural Resources from the Environment as much as they need to meet their basic requirements accordingly. Instead of using Diesel Generators we always support our local farmers to use Solar Power for irrigation purposes, which will reduce the emitting of Carbon Dioxide and other Green-House Gases into the Atmosphere. We also want to install some Bio-gas Plants at our rural locality for converting organic waste into energy under this Project. Due to last year our Tree Plantation Drives at our locality, we expect it will improve our Environment as well as to promote biodiversity in the wide range when all trees will become matured. As we promote sustainable agricultural works among

our local farmers, it will bring a positive impact gradually into our local Environment, that people has learnt to live with harmony of the Nature maintain the ecological balance and to build resilience avoiding the negative impacts of the climate changes.
