We are seeking for funds to enable us implement our environmental conservation and creation of awareness on the dangers of global warming.

### 1.2 Tell us more about your project and the impact it will have

The project is about environmental conservation and creation of awareness on causes and effect of global warming. The project aims at planting 1 million indigenous trees within one year. The indigenous seedlings are to be distributed to farmers. This will cover approximately 10% of cultivable hectares of individual farm. other seedlings will be planted to learning institutions, along the roads and river banks. This will help in reducing the amount of carbon dioxide emitted into the atmosphere. The trees will also act as water catchment areas and attracts rains which is beneficial to the farmers in the rural areas. The clean water for human consumption will also be available to the communities. The trees will also beautify the area making it to be more attractive.

Fruity seedlings will also be provided to the farmers and learning institutions. The fruity trees will act as source of income and act as source of vitamin that will help solve nutritional imbalance among the communities. The forest will reduce the harsh climate change. Trees planted along the farms will act as wind breakers hence reduce destruction of farm crops caused by strong winds.

The project is also aims at sensitizing the community about dangers of environmental degradation such as de-afforestation, overstocking, air pollution and pollution of water bodies. This will be done through workshops ad seminars. The community will be sensitized on the use of environmental friendly energy sources such as solar lamps and cooking gas which will reduce the cutting down of trees.

The will be implemented in Homa-Bay county, Rachuonyo North sub-county which is greatly affected by inadequate rainfall.

The direct beneficiaries of this project include: 1000 farmer drawn across Rachuonyo North sub-county, 100 learning institutions within the region, 5 hospitals and 10 churches. The indirect beneficiaries are the over 178,686 people living within the target region.

At the end of the project, the evaluation and auditing will be conducted by relevant authorities.
